- 4. Price: The E Waste Scrap lifting shall be at the prices as mentioned in the Annexure –I, TCS and GST shall be Extra (Payable to TIET as applicable).
- 5. Payment Terms: 100% advance payment to be deposited in Bank on the day of lifting.
- 6. EMD of Rupees 50,000/- (Rupees Fifty Thousand Only) is to be submitted by you in form of cheque (without date) and shall be retained during the period of contract and shall be released on the completion of contract.
- 7. Weighment of the E Waste Scrap items shall be done at TIET Weighing Machine, or at a mutual agreed location, whichever possible.
