### Terms & Conditions:

The amount shall be paid as one time scholarship to the student(s) who meet the following criteria mentioned against the respective scholarship. :

#### I)-Vinod Luthra, Sudershan Bhateja, Vijay Goel and Shyam Lal Taneja Scholarship 3<sup>rd</sup> year Mechanical

The candidate should be a BE 3<sup>rd</sup> year student of Mechanical Engineering and should have had no E or F or X grade up to 2<sup>nd</sup> year and having minimum CGPA 7.00 up to 4<sup>th</sup> semester of his/her study and have family income less than Rs. 10.00 lakhs P.A.

#### II)-Vinod & Vinay Luthra Family Scholarship 4<sup>th</sup> year Mechanical :

The candidate should be a BE 4<sup>th</sup> year student of Mechanical Engineering and should have had no E or F or X grade up to 3<sup>rd</sup> year and having minimum CGPA 7.00 up to 6<sup>th</sup> semester of his/her study and have family income less than Rs. 10.00 lakhs P.A.

#### III)-Vinod & Vinay Luthra Family Scholarship 3<sup>rd</sup> year Civil :

The candidate should be a BE 3<sup>rd</sup> year student of Civil Engineering and should have had no E or F or X grade up to 2<sup>nd</sup> year and having minimum CGPA 7.00 up to 4<sup>th</sup> semester of his/her study and have family income less than Rs. 10.00 lakhs P.A.

#### IV)-Vinod & Vinay Luthra Family Scholarship 4<sup>th</sup> year Civil :

The candidate should be a BE fourth year student of Civil Engineering and should have had no E or F or X grade up to 3<sup>rd</sup> year and having minimum CGPA 7.00 up to 6<sup>th</sup> semester of his/her study and have family income less than Rs. 10.00 lakhs P.A.

#### V)-Thapar Institute of Engineering & Technology 'Class of 1962 Scholarships' :

- i) 3 Scholarships for 2<sup>nd</sup> Year Students : The candidate should be a BE 2<sup>nd</sup> year student of Civil, Mechanical and Electrical Engineering ( **one scholarship in each stream will be awarded**) and should have had no E or F or X grade up to first year and having minimum CGPA 7.00 up to 2<sup>nd</sup> semester of his/her study and have family income less than Rs. 10.00 lakhs P.A.
- ii) 1 Scholarship for 3<sup>rd</sup> Year Students : The candidate should be a BE 3<sup>rd</sup> year student of Electrical Engineering and should have had no E or F or X grade up to first year and having minimum CGPA 7.00 up to 4<sup>th</sup> semester of his/her study and have family income less than Rs. 10.00 lakhs P.A.

#### **VI)-Kanwaljit & Zenaida Dhir Family Scholarship :**

The candidate should be a BE 4th year (**female**) student of Electrical Engineering and should have had no E or F or X grade up to 3rd year and having minimum CGPA 7.00 up to 6<sup>th</sup> semester of his/her study and have family income less than Rs. 10.00 lakhs P.A.

#### **VII)-Thapar Institute of Engineering & Technology, Class of 1988 Scholarship :**

- i) The student should be a BE third year student of either Civil, Mechanical or Electrical Engineering discipline and should have had no E or F or X grade up to the first semester of the third year of his/her study.
- ii) The candidates with a AGPA of 8.00 up to second year having annual family income less than Rs. 10.00 lakhs.
- iii) The scholarship shall be decided on the basis of family income, but satisfying the minimum criteria of AGPA. In case of same family income, the student having more AGPA shall be awarded the scholarship. If the AGPA is also same, then CGPA of the previous year would be considered for the award of scholarship.

#### **VIII)-Thapar Institute of Engineering & Technology, Class of 1989 Scholarship :**

- i) The student should be a BE second year student of any stream and should have had no E or F or X grade up to the first semester of the second year (i.e. up to 3<sup>rd</sup> semester) of his/her study.
- ii) The candidate with a CGPA of 6.00 up to first year having annual family income less than Rs. 10.00 lakhs..
- iii) The scholarship shall be decided on the basis of family income, but satisfying the minimum criteria of CGPA. In case of same family income, the student having more CGPA shall be awarded the scholarship. If the CGPA is also same, then AGPA of the previous year would be considered for the award of scholarship. If AGPA remains same then total marks of previous (two semesters) year will be considered.

#### **IX)-The Alumni of 1973-1977 Batch Scholarship :**

- i) The student should be a BE / B.Tech of any stream.
  - ii) The candidate with a CGPA of 7.50 and above and annual family income less than Rs. 10.00 Lakhs will be considered. Income criteria to be followed, No backlog at the time of applying for Scholarship.
  - iii) The scholarship shall be decided on the basis of family income, but satisfying the minimum criteria of CGPA. In case of same family income, the student having more CGPA shall be awarded the scholarship. If the CGPA is also same, then AGPA of the previous year would be considered for the award of scholarship. If AGPA remains same then total marks of previous (two semesters) year will be considered.
- 
- **The above mentioned scholarships shall be decided on the basis of family income, but satisfying the minimum criteria of CGPA. In case of same family income, the student having more CGPA shall be awarded the scholarship. If the CGPA is also same, then AGPA of the previous year would be considered for the award of scholarship. If AGPA remains same then total marks of previous (two semesters) year will be considered.**
